**Welcome to stock trading via an Alternative stock market!**

After de-listing from the Stockholm Stock Exchange on the 12 of December, Ballingslöv International's board of directors wants to give existing shareholders the opportunity to continue trading. The choice has fallen on the Alternativa aktiemarknaden Sweden (the company name translates to Alternative stock market, here after called Alternativa). In consultation with the company's board, Alternativa decided to open trade in the stock.

**Shareholders in Ballingslöv International AB:**

As shareholders in Ballingslöv International AB, Alternativa offers you from January 7, 2009 an opportunity to participate in organized forms of trading in Ballingslöv International's share. Ballingslöv meets Alternativa requirements and the financial information on the company website has been assessed as Excellent - MVG - according to Alternativa criteria. Trading in Ballingslöv shares will be 2 times a month with the first trade date on January 7, 2009.

**Alternativa aktiemarknaden:**

Alternativa (Alternative stock market) is a securities institute and is since 2003 under the supervision of the Swedish Financial Supervisory Authority (FI). Our business currently involves trading in shares and providing stock market related services to more than 30 companies. Trading takes place regularly but not on a daily basis, currently up to twice a month. Each trading period consists of four days. Of course, do not hesitate to continue using your own bank to make up smaller private business or transfers as inheritance or gift.

**Easy Registration and Information:**

To trade, you need to register as a customer at Alternativa. Registration is free and takes place on a form available on the website [www.alternativa.se](http://www.alternativa.se). You can also call us at +46 8 - 673 17 90 and we'll send you a form. As a registered user, you will also get current information about what is happening in and around our companies. Information and reports from Ballingslöv will be published on both companies' webpage's. On Alternativa, there are now nearly 3.500 private and institutional investors registered. By banks and stockbrokers acting on Alternativa, we reach a lot more people.

**The Trade:**

During each trading period **one** price is determined after the initial two-day order entry (7-8 January). Buy and sell orders are placed, via e-mail [info@alternativa.se](mailto:info@alternativa.se) or phone directly to Alternativa.

During the following trade, there is now, on the third day (January 9) a **fixed** price for Ballingslöv. Incoming orders are then received to the fixed price, between 9 and 12 of January. After completing the trade, contract notes with payment and delivery instructions will be sent to those who conducted closure. There is a fixed price (commission) of 150 SEK per business for the sellers and buyers, after agreement between Ballingslöv and Alternativa.
